Place and program of the event:

Maccagno, lago Maggiore, Italy . 02-05 Agosto 2008

Friday, August 1st, 2008, 18.00: Opening briefing, with all teams and the organizing committee

Saturday, August 2nd, 2008

09.00: Weight and controls.

11.30: Skippers Briefing with the Race Committee

13.00: warning signal for the first race.

If possible a total of 10 races will be held, no more than three races per day.

Sunday, August 3rd, Monday, August 4th 2008: races

Tuesday, August 5th, 2008: races. No warning signal will be given after 16.00. To follow: prizegiving.

Boat park and launching:

Boat park and launching area will be located at Parco Giona, Vehicles must be parked in the designated places. It is forbidden to enter with vehicles in the boat park area. Access to Parco Giona for competitors vehicles will be allowed showing the PASS that will be released from the Race Office upon registration.

Rules:

The regatta will be governed by the 'Rules' as defined in the ISAF 2005/2008 (RRS) Racing Rules, the individual Class association rules, this Notice of Race, Sailing Instructions and their modifications.

Rule modification:

RRS Rule 44.1 is modified from: "*Her penalty shall be a Two-Turns Penalty*" into: "*Her penalty shall be a One-Turn Penalty*".

Advertising:

Regulation 20 ISAF, advertising code, will rule.

Eligibility:

ISO and BUZZ class yachts with regular class registration shall be admitted. Italian competitors shall submit their FIV licences valid for the year 2008 with medical stamp and third party insurance. Foreign competitors shall comply with their national rules and must have a valid third party insurance.

All relevant documents should be shown to the Organizing Committee upon completion of registration.

Third party insurance:

Each boat shall have a current Public Liability and Third Party Property Insurance policy, including coverage when racing at the venue of the Eurocup, of not less than € 1.000.000,00. The policy must be show at the completion of registration.

Registration and Entry:

Entry fee is Euro 140.

All entries should be received (by fax, mail or email), together with the entry fee (see below for direct bank transfer) not later than July, 10th, 2008. Entries received after this date will be accepted at discretion of the Organizing Committee, for late entries the fee shall be of Euro 160. UK competitors can send their registration form and entry fee (£116 or £135, as applicable, payable to ISO Class Association) to Steve Bell, 30 Avon Way, London, E18 2AR. e-mail: steve@stephenbell.com. All entries and fees after 15th July **must** be sent to the organizing club.

Score:

The Low Point System will be used, as in RRS Appendix A (A2, A4.1).

Sailing instructions:

Sailing Instructions will be available at the Organizing Committee Secretary from Friday, August 1st 2008 at 15.00 upon completion of registration.

Prizes:

The number of prizes to each class will be decided according to the number of participants and communicated at the beginning of the event. Souvenir to all participants.

Liabilities:

As per RRS Fundamental Rule 4, it shall be the sole responsibility of the helmsman to decide whether or not to race or to continue the race. The Organizers, the Race Committee and the Jury decline any responsibility whatsoever for damages that might occur to persons and/or objects, both ashore and on the water, as a consequence of their participation in the races. All competitors will race at their own risk and responsibility.
